Non Renewal of the Certificate within the time limit will result in loss of eligibility for insurance coverage and appropriate legal action by Local Self Government / Revenue Department. All Officers of and above the rank of Station Officer of the Fire & Rescue Services Department will have the right to inspect the building on any day / time to ensure that the installed systems are in good working condition.

This Certificate pertains only to the Fire Fighting arrangements made and installed in the Building. The civil construction, eligibility of the land and plot for this project, environmental feasibility, survey details, etc. shall be got inspected and approved by the concerned competent

authority.
